- Rescission of authorization to purchase insurance for snow blowers from Brown&Brown
- Review of newly received insurance proposal from Scottsdale. Discussion and vote to authorize the purchase of insurance on snow removal equipment

Discussion: another insurance proposal was received by the treasurer after the last special meeting. This policy is comparable to the policy proposed by Brown & B Brown, but cost \$4000/year less. Nationwide owns Scottsdale insurance.

- Resolution to transfer funds within the current snow removal budget to pay for insurance

The treasurer needs to move funds within the current snow removal budget in order to pay for these insurance policies in full. It was moved by B. Benton to accept Resolution 2021-203-A authorizing the PCSD treasurer to submit a revised fiscal year 2021-2022 budget to the County of Tulare showing a transfer of funds in the amount of \$3,000 from object 740/2010 Snow, line 7430 Contingency to 740/2010 Snow, line 7010 insurance expense.

S. Alexander seconded the motion which carried with 3 ayes and none opposed.
