There was general discussion that insurance was immediately needed, and no other quotes had been received. Ms. Benton thought that the cost was fair since it included comprehensive coverage for both snow blower machines. Mr. Alexander and Mr. Cavagnaro would have liked to see competing quotes but understood the necessity of coverage. B. Benton moved to accept the insurance proposal from Brown & Brown. S. Alexander seconded it. The motion carried with 3 ayes, and none opposed.

2. There is a need to ratify the purchase of insurance for the snowplow truck. Ms. Benton unilaterally made the decision to authorize our current insurance broker to arrange purchase of insurance without consulting the other members of the board. Ms. Benton defended her actions as immediately necessary since there was a snowstorm due and the truck could be needed.

Mrs. Robertson explained that while the situation was understood, the proper course of action was to let the policy lapse, call for a special meeting, and have the rest of the board authorize our insurance broker to make the purchase.

Per attorney: Legally, the transaction is not a District transaction unless the Board approves it (so as of now it is a personal transaction undertaken by Beth, and the decision is subject to nullification with her being financially responsible for all consequences). I suppose the Board could notice a special meeting (24 hours notice), meet and consider the action and decide whether to 1) ratify it as a Board decision, or 2) decline to ratify the action and admonish the President that individual unilateral actions are not authorized.

I'd recommend letting the President know that she could be on the hook for that transaction personally, and that there are major legal ramifications to taking unilateral actions and with the presumption that the Board will ratify them. In this case, because insurance is a professional service, the 3 bids are not necessarily legally required (but of course a typically a standard and good practice for public agencies).

J. Cavagnaro moved to ratify the purchase of insurance for the snowplow truck. S. Alexander seconded the motion. The motion carried with 3 ayes, and none opposed. The purchase of snowplow truck insurance is now a district transaction, and the balance of the policy will be paid by the PCSD treasurer. Ms. Benton will be reimbursed, by the district, for her personal expense in securing the policy.

Mr. Griesbach added that although the intentions were good in securing the insurance for the truck, it is necessary to always follow proper protocols. No board member, regardless of title, can act individually and unilaterally to commit district funds, set policy, or enter a contract without the full board's authorization.
